CityU students win best corporate governance paper award

Text adopted from CityU NewsCentre (19 October 2012)

A paper co-authored by two students from City University of Hong Kong (CityU) has won the best paper award in The Hong Kong Institute of Chartered Secretaries (HKICS) Corporate Governance Paper Competition 2012. The pair also won the best presenter award for their outstanding presentation.

The paper submitted by Sardonna Wong Ka-yi and Ken Chan Wai-kit, Year 3 students in the Department of Accountancy, is written according to the given theme of "The 21st Century Board: What is an Effective Board?"

Organised by HKICS, the competition aims to promote stronger awareness of the importance of good governance among university students. It was open to all undergraduate students at local universities.

The CityU team's paper was shortlisted as one of the six finalists. The other five teams came from The Chinese University of Hong Kong, Hong Kong University of Science and Technology and Hong Kong Baptist University. All six finalists were invited to give a presentation before a panel of judges.

During the 15-minute presentation, Sardonna Wong and Ken Chan used the Enron Corporation to illustrate some of the loopholes related to



corporate boards and provide several recommendations to improve the culture and effectiveness of modern corporate boards.

The team's strong presentation of their insightful paper won them both the best paper prize and the best presenter award.

"We are pleasantly surprised. Some of the competing teams had very strong presentation skills," said Sardonna Wong.

The judges said they were impressed by our lively and well organised presentation and use of real-life examples to demonstrate our arguments, she added.

According to the organiser, the winning paper should reflect the best in originality and clarity of content, robustness of analysis and strength and merit of recommendations.

The CityU team won a HK\$15,000 cash award. In addition, the paper will be published in the monthly HKICS journal.

### Year 1 **AC Students** Top ACCA **Hong Kong** Competition

A proposal co-authored by a group of Year 1 students from the Department of Accountancy was ranked amongst the top 5 finalists in the ACCA Hong Kong Business Competition 2012. Two other CityU AC teams ranked in the top 15, receiving judges' commendations.

Organised by ACCA Hong Kong, the Business Competition aims to equip accounting students with thorough analytical, business proposal writing, presentation and communication skills through working in a team environment in a challenging, real-world business situation. This year, teams were invited to submit proposals for a government grant to help develop creative industries in Hong Kong.

The Year 1 students, Chung Pak Hei, Fung Tsz Ying, Lui Sin Man and Szeto Chi Yan, were invited to give a presentation on their proposal before a panel of judges at the Langham Place Hotel on 1 December. They discussed their idea of a consulting firm named Di, which digests clients' problems and seeks diverse solutions in supporting and promoting the music industry.

"The greatest difficulties we faced were the composition of the business proposal and preparation for the final presentation. Luckily, we got helping hands from professionals and our professors," Chung Pak Hei said .

The other two CityU teams created MAIR, a company dedicated to promoting classical music, and Dream Planting, a company providing green services in the architectural field.

The ACCA Hong Kong Business Competition received outstanding support from the Big 4 accounting firms, with partners from Deloitte, Ernst & Young, KPMG and PwC serving on the judging panel.

Awards of recognition were given to the participating firms, and Professor Yi delivered a speech. Let's take a look at what he had to say:









Our Overseas Internship Programme provides students with a challenging, discovery-driven learning experience through which they not only put skills into practice but also accustom themselves to different working cultures in overseas workplaces.

During their internships, students are assigned to a variety of client service engagements ranging from Fortune 500 multinationals to small businesses.

Exploring the unknown is an integral part of the programme, enabling students to become more flexible and adaptable in an increasingly globalised, technologically advanced society.

Being in a foreign country also provides interns with insights into the business practices of other cultures. By overcoming intercultural problems and challenges abroad, they fine-tune skills they can internalise and gain a broader view of what is happening in the world around them.



We served 300 guests with international food too!"

On 1 December 2012, the Department invited Dr Pok Man Kam, the Chief Executive Officer (CEO) of the Financial Reporting Council (FRC) and Adjunct Professor in the Department, to give a Joint Professional Seminar entitled "Some Common Issues Identified in the Review of Financial Statements" at the CityU SCOPE Learning Centre in Admiralty.

This was the first Joint Professional Seminar held in conjunction with not one or two but three accounting organisations: the Association of Women Accountants (Hong Kong) (AWAHK), the Canadian Certified General Accountants Association of Hong Kong, and the Society of Chinese Accountants and Auditors. Over a hundred participants, half of whom were CityU alumni, attended the event, which also counted towards the Continuing Professional Development requirements of those in the accounting profession.

The seminar helped to shed light on many issues commonly encountered when reviewing financial

statements. With his abundant experience as both CEO of the FRC and President of the HKICPA from 1999-2000, Dr Kam was the perfect candidate to deliver a presentation on the topic. Some of the items discussed included non-compliant reporting of business combinations, operating segments and the impairment of assets.

The Department would like to thank all those who attended and supported the event, particularly Dr Kam for giving the talk, and our co-hosts. We are proud to have had one of our own Adjunct Professors transfer knowledge to our alumni. This initiative reflects the Department's continued efforts to support its students beyond graduation and well into their careers.

Professional Seminar



The Department regularly invites subject matter experts to give guest lectures for students. In June 2012, it was our honour to have Mr Peter Kung, a tax partner at KPMG, spare the time to speak about Chinese taxation.

Mr Kung discussed the latest developments in the mainland Chinese accounting industry and explained the current tax system in detail. He exchanged ideas with the students and used interesting real-life cases to illustrate how to design a corporate structure that would be beneficial for tax planning.

He also provided valuable career advice for the students and offered a few tips for

succeeding in both the Hong Kong and mainland job markets. He suggested that students be forward looking, maintain positive attitudes towards their careers, and most importantly, "sleep well!"

Mr Kung is a veteran tax partner at KPMG with two decades of professional accounting and taxation experience in southern China. He also spent ten years working in the United Kingdom before relocating to China.

Students who are interested in learning more about taxation in China can enrol in AC3252-Accounting and Taxation Systems in the Chinese Mainland, which is offered by the Department.

ater that week, the students visited a Fairwood restaurant to gain a complete on-the-spot understanding of the company's operations. The one-hour tour of the restaurant and its kitchen allowed them to understand the payment and service methods relevant to a fast food corporation. Talks with Miss Mak on Fairwood's quality control system, the operating margins required and the financial measurement of return on average equity investment enabled the students to benchmark the company's performance against that of the market, the anticipated competition in the Greater China market and even general issues such as the automation of dish-washing!

Assignment-based coursework such as this is providing our students with the opportunity to develop practical skills prevalent in business – the ability to act, think and deliberate on innovative and focused ideas as professionals – which will prepare them to be multifaceted individuals with strong career paths.

Under the guidance of Dr Margaret Poon, an Associate Professor in the Department of Accountancy and the course instructor, the students gained a thorough knowledge of financial concepts and undertook an in-depth analysis of their application in the business world. Through the assignment, the students had the opportunity to financially measure the efficiency and effectiveness of the company's operations.

A seminar and site visit held in September 2012 ensured that the students had a full understanding of the company's past performance, current operations and potential development.

Mr Chan Chee Shing, Fairwood's Chief Executive Officer, and Miss Mak Yee Mei, Fairwood's Chief Financial Officer, were welcomed by the class at CityU on 17 September. Mr Chan discussed the company's past and current operations and explained the changes that the company had to make to keep up with its competitors. He related that company had been through ups and downs, and that it would experience more growth in the future. The students learned about Fairwood's corporate culture and its branding policies, enabling them to develop a sense of the overall business operations.

Miss Mak presented the company's financials and discussed issues related to equity financing, cost control and the associated foreign currency risks. She provided the class with valuable insights into the headstrong attitude of the company during its financial struggle to prevent bankruptcy. After the presentation, the students asked thoughtful questions covering topics ranging from the government's minimum wage policy and its impact on the company's labour costs to the key performance indicators that the management had set. Mr Chan and Miss Mak answered with patience, focusing on the ethical aspects of operating a service-based company, the major market risks involved and the company's hedging strategy.

On 30 August 2012, the Department arranged an Orientation Day for freshmen under both the three-year curriculum and the new four-year curriculum, which are being offered concurrently this academic year (2012-13) as CityU transitions to the new academic structure. To inspire the new cohort and motivate our existing students, we talked about success with Thomas Lee and Wendy Yim, two fresh graduates who received multiple offers from the Big 4, and Tracy Chan, a Year 3 AC student who represented Hong Kong on the Pilot Scheme for Cross-Border Study Tour.





## Study: A necessary but insufficient condition

Excellent academic results are only the first step on the path to success, especially for accounting students who want to be hired by the Big 4 accounting firms.

Wendy Yim, a young lady who secured three Big 4 offers, joined PwC, the world's largest accounting firm in terms of revenue, in September 2012. Speaking of her accomplishments, she emphasised that good grades alone were not sufficient for success. She suggested that "you also need to take part in extracurricular activities and internships to nurture skills and abilities that make you stand out from the crowd."

Wendy spoke from personal experience: she did not perform well in her high-level examinations and could only enrol into an Associate Degree programme, which served as a wake-up call to get her studies back on track. After many days and nights of hard work, she successfully transferred to a Bachelor's degree programme. After that, she grasped every opportunity for exposure to the accounting industry.

Thomas Lee, an outgoing young gentleman who joined PwC in October 2012, agreed with Wendy's comments. He said university life is not really a honeymoon period, but a period in which to develop your own interests and dedicate yourself to a cause. During his three years at CityU, Thomas was a member of the taekwondo team and worked as a part-time taekwondo trainer. Intensive training, together with a heavy academic workload, dominated his university life. He suggested that preparation is paramount when hunting for Big 4 offers. He began preparing for his Big 4 applications at the beginning of his final year, and composed more than seven pages of mock interview Q&As covering a wide range of social, economic and personal issues.













# Study Tours: Getting a global perspective

Study tours also make up an important part of AC students' university life. Tracy Chan, a final year student, was honoured to take part in the Pilot Scheme for Cross-Border Study Tour for Post-Secondary Financial Talents organised by Hong Kong Financial Services and the Treasury Bureau. Tracy spent six weeks in Shanghai, visited some of the most important Chinese government financial bodies and worked in an international financial corporation. This was an eye-opening opportunity for her to witness the latest developments in the Chinese finance industry.





Thomas and Wendy also took part in a study tour to the United Kingdom. They spent a few weeks in the UK suburbs, volunteering for charity organisations during their homestays with local families. Wendy said that the experience helped her to become a more independent person, as she learned how to take care of herself. Thomas added that this was also a meaningful tour for him. He volunteered for a charity organisation named Global Care and helped to raise funds for refugee children in Africa, which broadened his horizons beyond his own immediate environment.

Such valuable overseas experience is very important in shaping students' global perspectives, strengthening their exposure to the real world and developing them into more well-rounded professionals.

# **Internships:** A taste of real-life accounting

Apart from professional training and overseas studies, the hands-on experience of applying what they learn is also important in sharpening students' competitive edge.

During his summer internship at Crowe Horwath, an international audit firm, Thomas travelled to factories in Xi'an and Shenzhen for auditing work. These trips proved challenging but they gave Thomas his first taste of what auditors do in real life. Wendy learned how to be more confident and communicative during her time at the HKSAR government's Inland Revenue Department. Tracy was able to constantly interact with management in discussing and resolving issues, which help her to develop business sense and made her consider working in Shanghai upon graduation.

Internship opportunities are valuable and meaningful for students, allowing them to understand the real industry landscape.







# Self-resilience: Moving ahead and overcoming weaknesses

Outstanding professionals always have strong minds, and they are able to overcome the difficulties and challenges they face. All three interviewees demonstrated the ability to learn from failures and overcome weaknesses, which enabled their success.

Wendy was once an introverted, lackadaisical girl who tended to daydream more than think about what lay in the future. During the last few years, however, she convinced herself to leave that behind, gaining confidence and moving forward day-by-day. She has graduated from CityU with a sense of achievement, and with a bright future ahead of her. She could not have achieved this without a strong mentality and a positive personality.

Similarly, Thomas has a resilient character and tough personality built through years of taekwondo training that focused on strengthening his mind and body. When facing difficulties, he tries to stay calm, prioritise issues and solve each problem step by step. That explains how he managed to keep up with his taekwondo practice amidst a heavy workload and extracurricular activities.

Tracy was impressed with Wendy and Thomas' sharing and wanted to follow the same path. She admitted to a certain degree of shyness and was looking into ways of overcoming that weakness in a bid to secure a promising future.

Wrapping up the interview, Thomas likened his time at CityU to a vast ocean of opportunities, where an abundance of wealth lies beneath the surface. "All you need to do is to equip yourself and reach as far and wide as possible."
