Meeting in the Cloud to Seek Development Together — The 2022 Annual Conference of China Journal of Accounting Research

The 2022 Annual Conference of China Journal of Accounting Research (CJAR) was held online with success on 26-27 November 2022. The successful conference was co-organized by City University of Hong Kong (CityU), the Center for Accounting Studies of Xiamen University, and Sun Yat-sen University.

The opening ceremony in the morning of 26 November was hosted by Professor Zhifeng Yang from Stony Brook University. Professor Junsheng Zhang, CJAR Editorin-Chief and Associate Dean of Sun Yat-sen Business School delivered opening remarks and wished for the great success of the workshop conference.

The topic of the first keynote speaker, Prof. Michal Matejka (Arizona State University), was "Economics of Performance Target Setting: Theory and Empirical Evidence.".
