## **Tremendous Support from My Home Department**

During my freshman year, I was having a hard time adapting to the new learning environment. The Department of Accountancy was truly appreciated in helping me discover various learning opportunities. In November 2017, I paired up with my classmates from the Department of Accountancy and Finance to participate in the ACCA Hong Kong Business Competition. The journey we took was tough but rewarding. We were required by the organization to write an unreasonably short yet comprehensive business proposal for a social enterprise based in Singapore, named ASKI Global, a non-profit making organization that aimed to help migrant workers and their families become financially literate and independent through entrepreneurial coaching and training. In our proposal, we had to include financial and competitor analysis to identify the reasons driving ASKI Global's lack of financial sustainability. Eventually, we developed an e-learning platform using Google Classroom to render a low-cost service so that a high market share could be captured. Financial modeling and revenue prediction are always difficult for me, given that I have no related experience. The professors in our department are always willing to give us insightful advice and introduce us to professional alumni for further advice. Without their generous help, I believe our team would not have gone as far as the top 20 out of 350 teams from local institutions in Hong Kong.

#### **Global Exposure**

Global experience is a matter of utmost importance in the era of globalization. Apart from having classmates from every corner of the globe, BBA students are very likely to work in multinational corporations and must cope with colleagues from diverse backgrounds. Hence, I grasp different overseas opportunities to broaden my horizons. Apart from the Overseas Exchange Program which most students join, in 2017. I participated in the Seoul Study Tour organized by the College of Business Young Scholars Program (YSP). Thanks to the host, Seoul National University, we were able to visit a number of Korean corporations including MBC Broadcasting, Amore Pacific, Hyundai Motors Factory and Studio, Samsung Electronics and the KRX Korea Exchange. The visit to "SKY," which refers to the top three universities in Korea (Seoul National University, Korea University and Yonsei University), was particularly memorable, as we participated in networking sessions with business students there.

In May 2018, I had another remarkable global experience—the Singapore Study Tour organized by the CityU Student Ambassador Programme. The most fascinating part of the tour was being inspired by the comprehensive urban development reflected in the infrastructure, ranging from the New Water Visitor Centre to the inclusive multicultural environment and the government policy address. Singapore has achieved water self-sufficiency by deploying revitalized water strategies to meet 50% of water demand, while Hong Kong is not doing a great job in water resources management and heavily relies on Dongjiang water from mainland China. The insights gained during the tour definitely helped us to analyze social issues in a more holistic way and to solve problems with far-reaching designs. The school visit to the National University of Singapore was also fruitful. We got the chance to network with NUS student ambassadors and shared our HK-Singapore learning experiences and views on cultural differences. In particular, we discussed differences between our ambassador programs. There is so much to learn from the NUS ambassador organizational structure, which is divided into departments such as the secondary school outreach team, MC team and school tour team. This practice achieves a division of labor so that ambassadors who are good at a specific area are assigned to the corresponding department to enable the right person to serve in the right position.
