#### Tips from Experts who Aided Students' Career Development in China

In line with its booming economy, and to maintain its rapid development, China has great demand for professional accountants. On 16th September 2009, two representatives of KPMG Huazhen delivered a seminar entitled "Career opportunities and challenges for our graduates - the experience in China". This informative

seminar familiarised AC students with the challenges of and opportunities for working as a practising accountant in China.

More than 70 students attended the seminar. which was presented by Ms Maggie Lee, an audit partner at KPMG, and Mr Philip Li, a senior manager at the firm. They gave the

students their insights about the auditing profession in China, and advised the students on how to prepare themselves to work there.





#### **Workshop Prepares Students for Internships**

**E**very year, the Department cooperates with different accounting firms to provide students with internship opportunities that can facilitate their career development. We also organise different kinds of workshops to equip students for their placements in large corporations.

#### Pre-Internship Development Workshop

**O**n the 19th and 20th of December, the Department organised a pre-departure internship workshop for interns who are going to work locally or in Singapore. This workshop provided them with basic audit knowledge, thus enabling them to better cope with the competitive working environment of international accounting firms such as Grant Thornton, RSM and the local Big 4.

The workshop was run by Mr Kit Wong, a CityU alumnus who works as a trainer in a local Big 4 firm. In addition to explaining what an audit is and providing basic training in auditing procedures, evidence and methods, Kit also discussed office etiquette and different organisational cultures with the students and provided them with tips to improve their communications skills. This two-day training workshop served as a baseline for students, as it provided them with some of the most vital survival skills they will need to thrive in an international accounting firm.

#### Sharing Session with Previous Interns

n addition to preparation workshops presented by accounting professionals. previous interns were also invited to share first-hand information regarding their

internship experience with upcoming interns. A dozen interns who had taken part in internships in 2009 gathered on the morning of 19th December to discuss their life and working experiences with future interns.

Ken Chan, a year-3 accounting student who went to Singapore on an RSM internship in 2009, was eager to share his experiences there with his fellow schoolmates. Ken gave them some essential tips on dress codes. time management and communication skills. He said he thought his internship, which provided intensive on-the-job training, had



#### Prof. John to "Retire" after 19 years at CityU

I started at City University of Hong Kong on 1 September 1991 with the intention of working here for nine months. In August 2010, 19 years later, I will commence "retirement" on the Gold Coast in Australia. The decision to come here was one of the most satisfying I have made in my life. When CityU was a Polytechnic I served on 16 committees and over the years obtained a range of invaluable administrative, teaching and research experiences.


Students have changed in a number of ways - they are now more sophisticated, articulate, focused, ambitious, worldly, confident, industrious and demanding. The composition of teaching staff has undergone much turnover and the composition of the student population reflects increasing internationalism. These changes are to be expected in the evolution of an institution with the kind of aspirations expressed by CityU. Despite all the changes that have occurred, the Department of Accountancy retains its family ethos, with a caring attitude towards whole person development. This Department can be proud of the empowerment of its students and the professional work ethic imparted on them over their three year stay with us.

Entering a new educational process is an



exhilarating time for an undergraduate. I can still remember the excitement I felt when I bought my first university textbook in 1962, a year when some of your parents had just been born. While the workload of a professionally-oriented degree is heavy at times, that is a good thing. Accountants are busy and important people and learning how to cope with assignment and examination deadlines and the high expectations of others is excellent preparation for the

Accountants bring order into business by ensuring that a permanent and verifiably accurate record of economic transactions is maintained. Accountants and accounting are essential elements of the governance process that





managers, clients and the public to interpret increasingly larger volumes of technical information.

University education, however, should not be all work. Play and social interaction are important aspects of the educational process. Make new friends and talk to them often, eat healthy food together. party hard, play sport, maintain or develop non-academic interests, join clubs, become involved in current affairs, read and talk in English, develop strong ethical principles, travel overseas as often as possible, and think always like a professional. Take one day at a time, but develop career goals as soon as possible when commencing university studies to add interest and commitment to your studies - you never know what clients might expect from you. Develop an e-portfolio from day one.

Accounting education is changing. Preparation and organization of financial information is essential but is not the end in itself. Accountants are actively involved in communicating the economic meaning behind the numbers and how these numbers can be used to help make rational business and investment decisions. Accounting and auditing standards are becoming more internationalized. The knowledge obtained by studying accounting and auditing is an overseas passport (or ticket), because that knowledge and its application are transferable often beyond national jurisdictions. What this means is that at the end of your degree and three years of relevant work experience you will be able to consider accounting, finance and managerial positions anywhere in the world, for accounting is a portable discipline. Worldwide job opportunities and the chance to meet and work with interesting people and companies are limited only by your own imagination and aspirations.

Like the medical and other professions, there is a growing need for greater specialization in accountancy. A first undergraduate degree should be viewed as the start of life-long education. After graduation and a few years of essential on-the-iob experience it will be time to consider a masters degree that will provide specialization in specific areas. There are many exciting new fields such as accounting for water resources, reporting implications of financial and non-financial issues arising from emissions trading schemes and carbon credits, distressed company restructuring and valuation, healthcare, matrimonial litigation, charities, international taxation modeling, hospitality, forensic accounting, corporate governance, risk management. and compliance reporting, to name a few examples. Not all universities have caught up with these changes so you will need to explore postgraduate study opportunities overseas as well as locally.

Climatic changes occurring worldwide produce increasingly unpredictable and serious outcomes. The world is changing too in other ways and for the remainder of your lives you will be exposed to these changes in one way or another. Changes will affect clients and their businesses here and abroad. Hybrid financial instruments, off-balance sheet items, joint ventures, technology, and international business transactions, as examples, will require carefully considered accounting treatment. You will experience situations where accounting standards are incomplete or lag behind economic reality and some situations where there are no "the' answers, only defensible responses appropriate for current circumstances. It is important therefore to examine these situations based on economic substance rather than on legal form. A sound understanding of the underlying concepts and their applications in specific situations are valuable tools for a good

accountant and will help resolve client difficulties and provide guidance.

No matter what else you accomplish in your university studies, it is crucial that you develop the skill of analytical thinking. Try too to improve your verbal and written communication skills. Thinking and communication are the two essential abilities that will allow you to excel in your professional careers and add net worth to society, which is a basic reason why you are planning to become a professional accountant. Be proud, be independent, be confident, be objective and fair, be thorough, be scrupulously honest, and have tons and tons of fun!
