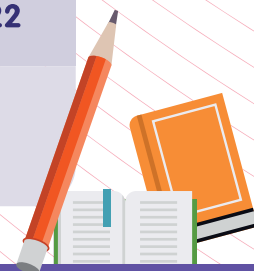

Personal Information Collection Statement

This Statement is made by Link Asset Management Limited (“**Link Asset Management**”), as manager of Link Real Estate Investment Trust (“**Link REIT**”) and Link Properties Limited (collectively “**we**”, “**our**”, “**Link**” or “**us**”), in accordance with the Personal Data (Privacy) Ordinance (Cap. 486) of the Laws of Hong Kong Special Administrative Region (“**the PDPO**”). This Statement intends to notify you why your personal data is collected, how it will be used, to whom the personal data will be transferred and to whom data access requests are to be addressed.

For the purpose of this Personal Information Collection Statement the following terms are defined as follows:

“Link University Scholarship” means the scholarship programme established by Link in 2015/2016 under Link Together Initiatives (defined below) with an aim to support undergraduates who are the first university students among the three generations of their families to study at one of the Hong Kong universities (“**Link Scholarship**”).

“Link Scholars Alumni” means a programme that provides activities and/or opportunities to broaden the horizon of all the awardees of the Link Scholarship.

“Link Together Initiatives” means the flagship charity and community engagement programme to support charitable organizations to launch service and/or community projects that benefit the communities near Link REIT’s properties, with the objective to advance sustainable development in the communities served by Link and to further Link’s vision of serving and improving the lives of those around us. Types of Personal Data

We will collect the personal data from the applicants including but not limited to the name, email address, gender, contact telephone numbers, school name (where applicable), position at school (where applicable) and other personal data as required under the application form of the Link's Programmes and photos/ videos taken at the activities held under the Link's Programmes.

Use - How Your Data May Be Used

Personal data held by us will be used in the following manner:

1. to facilitate the selection for application, administration (including checking eligibility and qualification), verification of identity, communication, liaison, updating, continuation, operation or related administrative matters of applications made to Link's Programmes;
2. to facilitate invitation, recruitment, promotion (including future promotion) on any medium or channel, liaison and communication of:
 - (a) Link Scholarship activities and events including promotional or marketing activities related thereto;
 - (b) Link Scholars Alumni activities and events such as volunteer service, community engagement project, seminar, company visit, mentorship programme, marketing events, school fairs, benefits, interview and sharing activities or any promotional or marketing activities related thereto;
 - (c) Link Together Initiatives activities and events including promotional or marketing activities related thereto;
 - (d) Link Summer Internship Programme recruitment and related activities (including promotional or marketing activities related thereto);
 - (e) Community services and related activities that promote sustainable development of the community referred by Link.
3. to facilitate invitation and promotion (including future promotion) on any medium or channel, liaison and communication of Link Management Associate and Management Trainee Programme recruitment and related activities.

(collectively "**Activities and Events**")

4. to facilitate internal statistics and analysis of the success of the Link's Programmes;
5. to make disclosure when required by law, regulation or court order of any jurisdiction and/or as requested by any government, regulatory or law enforcement authority or

administrative organisation, which may be within or outside Hong Kong Special Administrative Region;

6. to establish legal claims or defence; obtain legal advice, and/or exercise, defend and/or protect the rights or properties of Link, Link's contractors, agents and third party service providers of any of Link's Programmes including identifying, contacting or bringing legal action against any person who may be interfering with any such rights or properties (whether intentionally or otherwise) and/or where any third party may be harmed or property of any third party may be damaged by such interference.

You are not obliged to provide your personal data to us, but if you do not, we may not be able to use your personal data for the above purposes and in particular you will not be eligible for consideration or participation in any of the Link's Programmes.

If you are under the age of 18, you must obtain your parent or guardian's consent before providing any personal data to us.

Use of Personal Data in Direct Marketing

We intend to use your personal data in direct marketing, and we may not so use your personal data unless we have received your consent (which includes an indication of no objection to the intended use).

Furthermore, we intend to provide your personal data to all or any of the following parties (whether within or outside the Hong Kong Special Administrative Region) ("**Related Parties**") for use by them in direct marketing, namely any / or all the special purpose vehicles of Link REIT, the subsidiaries (if any) of Link Asset Management and/or Link Properties Limited and any agent, contractor or third party service provider so engaged by them. However, we may not so provide the data unless we have received your consent (which includes an indication of no objection to the intended provision). Please note that the personal data may be provided for gain by us.

We would like to use your name and contact details (such as telephone number, email address and/or correspondence address) for marketing the following services, products and promotional events through various communication means such as direct-mail, email, telephone, SMS, printed matter, newsletter, brochure and leaflet. The services, products and promotional events include but not limited to invitation, recruitment, promotion, liaison and communication of the Activities and Events of Link's Programmes, community services that promote sustainable development of the community referred by Link as well as materials facilitating invitation and promotion of Link Management Associate and Management Trainee Programme recruitment and related activities.

Transfer of Your Personal Data

Personal data held by us will be kept confidential, but we may disclose/transfer such data to the following parties (whether within or outside the Hong Kong Special Administrative Region) for the purposes set out in this Statement:

1. all the special purpose vehicles of Link REIT and the subsidiaries (if any) of Link Asset Management and/or Link Properties Limited, your secondary school and your university (if any) in connection with the operation of or in relation to the Link's Programmes;
2. any agent, contractor (including project consultant or coordinator) or third-party service provider of activities of the Link's Programmes who provides consulting, coordination, administrative, telecommunications, computer, payment, content, information or other communication or marketing and promotional services to us in connection with the operation of or in relation to the Link's Programmes;
3. any person under a duty of confidentiality to us or who has undertaken to keep your personal data confidential and use them in strict compliance with the requirements of the PDPO such as accountants, legal advisors and other advisors;
4. any government, law enforcement authority or administrative organisation; and
5. any person to whom we are under an obligation under law to make disclosure.
