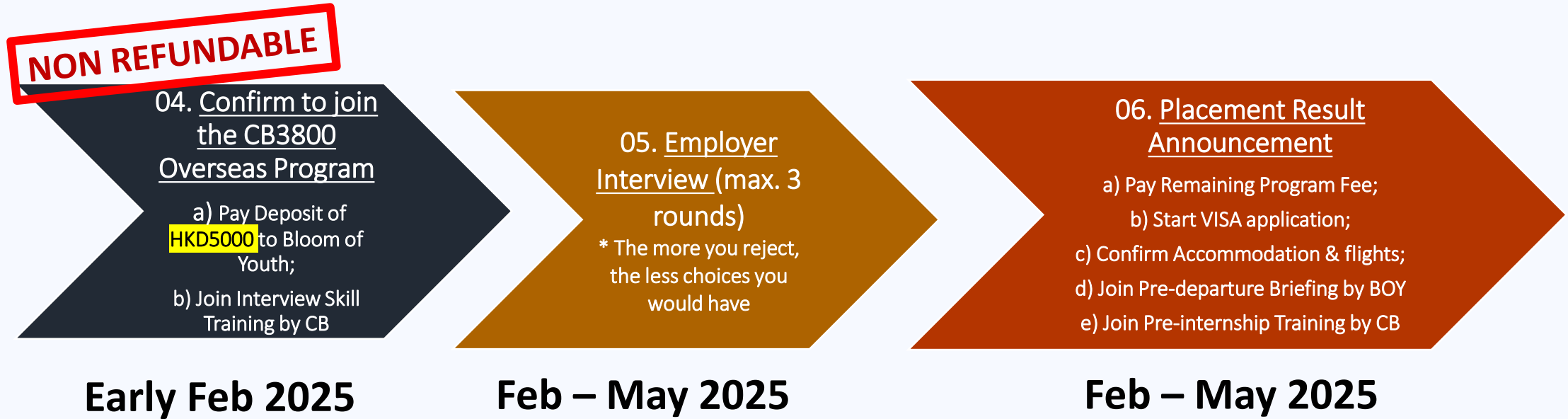

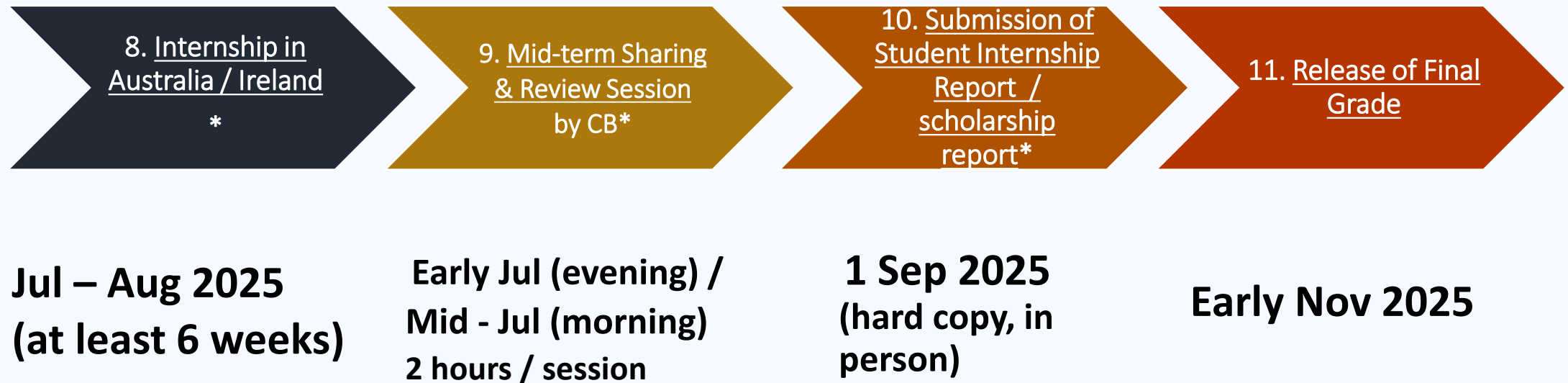

QUESTION YOU MAY HAVE (1)

1 What is the purpose for this overseas internship?

This is an opportunity for you to gain international work experience while immersing yourself in a new culture.

2 What are the sample jobs from previous BOY summer interns in Australia & Ireland?

SMEs (ranging from I.T, Accounting, PR & Marketing, HR & Talent Management, Hospitality, Events & Tourism, NGOs & Nonprofits, Real Estate, Finance & Economics, Education, etc.) located in **Sydney** or **Melbourne**, or **Ireland**.

QUESTION YOU MAY HAVE (2)

3 What are the selection criteria for the scholarship provided by CB3800 Overseas Summer Internship?

- CGPA 3.0 or above;
- Application indicating your interest of the programme, how you are planning to maximize the opportunity given;
- Interview screening calls (1 conducted by BOY, the other conducted by CB);
- Financial needs of the student; and
- Commitment on the internship.

4 When do I need to pay the deposit of HKD5,000?

Within a week after confirmation of successful application.

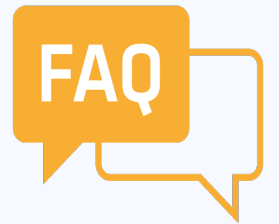
QUESTION YOU MAY HAVE (3)

5 How many rounds of job referrals are there?

Maximum 3 rounds of referrals. The more jobs you rejected, the less choices there will be for you.

6 Can I quit after confirming (with paying the deposit of HKD5000) to join the CB3800 Australia Summer Internship?

We would not suggest, but if you insist to quit, you won't be able to get back the HKD5000 deposit submitted, you will also get a failure grade (F) for this course which will be shown on transcript and, you won't be able to retake the course.



QUESTION YOU MAY HAVE (4)

7 How much in total for the whole 6 weeks internship?

Programme Fee: ~HKD37,050

Airfare: ~HKD10,000

Visa Application + Medical Exam: ~HKD4,681 (Australia)

Travel Insurance: (Covered by [CityU Group Personal Accident Insurance and Group Travel Insurance Policy](#) and SOS, students may choose to purchase additional medical insurance as necessary.)

Estimated total cost: HKD51,731 (exclude personal expenses)

Scholarship available: HKD25,000 (at most)

8 What if I get rejected by employers for all rounds of referrals?

If there's no job being placed by May 30, 2025, there will be full refund of the deposit.

9 Can I take leave during the internship?

During the internship period, leave application is not encouraged. If students need to take leave for special reasons, students should seek approval from the company.

10 Any scholarship available for this CB3800 Overseas Summer Internship Programme?

Yes, only successful nominees will be eligible for the subsidies (Up to 90% of actual expenses with a cap of \$25,000). subsidies will be reimbursed after completion of the internship.

11 Can I simultaneously take both CB3800 and FYP/other course(s) in Summer?

You are not encouraged and not recommended to do so.

16 When will the CB Scholarship (max. of \$HKD25,000) result be announced?

It will be announced together with the application result, around early Feb 2025. You have a week to decide whether you want to continue the participation of the CB3800 Australia Summer Internship Programme 2025. If yes, you can pay the deposit to continue your participation (meaning you are officially enrolled into CB3800. Any withdrawal after that will not be entertained and will be resulted in a failure grade.

17 When will the CB scholarship be reimbursed? Do I need to pay the programme fee on my own first?

Successful scholarship recipients who have completed the internship (with submitting the Student Internship Report), will receive the scholarship reimbursement (max. of HKD25000) by Feb 2026. Successful scholarship recipients please be expected to pay the programme fee on your own first.
