(1) English Language Requirements

Students admitted with HKDSE English Level 3 or equivalent are required to complete two 3-credit EAP courses, EL0200A English for Academic Purposes 1 and EL0200B English for Academic Purposes 2, prior to taking the 2 GE English courses (GE1401 University English and GE2402 English for Business Communication). Note: Students who demonstrate that they have achieved a grade B or above in their overall course results for EL0200A will achieve 3 credits and also be considered to have satisfied the pre-requisite for entry to the GE English courses without needing to take EL0200B.

(2) Gateway Education Course Distributional Requirements

This course will not be counted towards the minimum credit units required for graduation and will not be included in the calculation of CGPA. - c. First-year intake students other than (a) and (b), including mainland and non-local students are NOT required to take CHIN1001.
