Thesis title: The Delivery of Financial Consultation Services to Premier Customers - An Empirical Study on Interactive eChannel

Thesis summary: This research aims to understand the factors influencing the adoption of electronic channels by

customers. It focuses on channel choices, primarily through convenience, trust and efficacy of information acquisition pertaining to a channel, and the customer-relationship manager. It shows that cognitive capital between customers and the relationship manager weakens the relationship between perceived efficacy of information acquisition and the customer's adoption of interactive e-channel, but relational capital does not strengthen the relationship between convenience or trust and the customer's adoption.

Thesis title: Firm Survival and Success in Environmental Jolts: A Resilience Perspective and Evidence from Hong Kong Manufacturing Firms

Thesis summary: The risk of unanticipated and potentially detrimental environmental jolts requires firms to be resilient. This study investigates the

impact of resilience capacity on firm performance over a 3-year period following the 2008 global financial crisis. Using the data gathered from 207 manufacturing enterprises in Hong Kong, the study confirms that resilience is an important concept for surviving environmental jolts. Specifically, resilience facilitates survival and adaptation through adversity orientation and through access to critical resources from supportive networks and relationships.

Thesis title: Key determinants of debt decisions of Asia Pacific REITs with a focus on Sponsors and the impact of the financial crisis: Evidence from Japan, Singapore, and Australia

Thesis summary: I analyzed debt financing decisions of Asian REITs to see if presence of a sponsor had any

influence. My findings suggest that Asian REITs with sponsors have much higher levels of leverage and longer maturity debt than non-sponsored REITs, but are able to better manage the negative impact of higher leverage and longer maturity. I also found that compared to non-sponsored REITs, sponsored REITs were more proactive in reducing

Thesis title: The Contribution of Customer Knowledge to Innovation and Organizational Performance: A Dynamic Capabilities Perspective

Thesis summary: Customer knowledge helps organizations optimize resource utilization to address customer needs and wants to increase customer value. As one of the most valuable assets,

customer knowledge itself is not sufficient for organizations to achieve this objective because it only has meanings in the context of a process or capability to act. This thesis examines the underlying mechanism of converting customer knowledge into organizational outcomes (i.e. firm performance regarding monetary outcome and customer equity) through

Thesis title: Effects of Initial Trust in Doctor, Country of Origin, Price Sensitivity and Word-of-mouth on Medication Buying Intention of Chronic Disease Patients in China

Thesis summary: The objective of my research is to study the main and

interactive effects of initial trust in doctor (ITID), country of origin (COO), word of mouth (WOM) and price sensitivity of medication – on medication buying intention of chronic disease patients in China. The research supported the hypothesized positive effect of ITID and the major sequential effects of ITID and COO as the most influential marketing factor in altering the medication purchase intention of chronic disease patients in China.

Thesis title: The Influences of Industry Clustering, Social Capital and Knowledge Sharing on Technological Innovation Capability of Small Medium Technology Enterprises in Hong Kong Science Park

Thesis summary: Drawing on a knowledge-based view in addition to

social capital and absorptive capacity theories, this study develops a research model to investigate how industry clusters influence SMEs' technological innovation capability. In particular, it proposes that industry clusters have an indirect influence on that capability through social capital and inter-firm knowledge sharing. Furthermore, it shows that the relationship between knowledge sharing and an SME's technological innovation capability is moderated by the SME's absorptive capacity.



Thesis title: Chinese Product Innovativeness: Decomposing Its Dimensions and Their Relation with New Product Performance

Thesis summary: Building from the firm's perspective, this research examines Chinese product innovativeness's dimensions relative to new product performance, and

investigates the influences of product radicalness and the moderating effects of Chinese network ties "guanxi". A total of 178 Chinese technology firms participated in this study. The findings echo with western countries' studies which verify that new products fitting with marketing and technology competences tend to be successful. Contrarily, they indict the differential impacts of product radicalness. Furthermore, the results disrupt the previous research claims and challengingly foster the arguments on the capability function of management ties.
