Pursue a bright future



EY Young Tax Professional of the Year is an international competition designed to identify young talent with an interest in tax, help them enhance their professional skills and develop their careers. The competition gives participants the opportunity to share experiences with people from different backgrounds and cultures.

How the competition works

There will be a local competition, a national competition and an international competition. Each competition will test the tax technical, reasoning, presentation and communication competencies of the participants.

Who can apply?

The competition is open to undergraduates in their penultimate or final year, or postgraduates.

Local competition

The local semi-final will be held on 3 February 2018 (Saturday).

*A bonus course on international tax will be awarded to all semi-finalists on the same day.

The local final will be held on 1 March 2018 (Thursday).

*Winners of the semi-final competition will be awarded direct entry to our online test for internship/graduate program.

National and international competitions

The first- and second-prize winners of the local competition will represent Hong Kong at the national competition in Guangzhou on 31 March 2018 (Saturday).

The first-prize winner of the national competition will represent Greater China at the international competition which will take place in Europe in late 2018.

Enter the competition to win:

- ▶ A 30-day round-the-world business trip
- ▶ Attractive cash prize
- ▶ An internship/graduate job offer

Local prizes

- 1st prize: HK\$8,000 cash, a 6-week paid internship or conditional offer of employment with EY's Tax Department in Hong Kong.
- 2nd prize: HK\$6,000 cash, a 6-week paid internship or conditional offer of employment with EY's Tax Department in Hong Kong.
- 3rd prize: HK\$4,000 cash, a 6-week paid internship or conditional offer of employment with EY's Tax Department in Hong Kong, and stand-by participation as Hong Kong's representative at the national competition.

National prizes

- 1st prize: HK\$20,000 cash, a 4-week paid internship or conditional offer of employment with EY's Tax Department in Greater China.
- 2nd prize: HK\$10,000 cash and a 4-week paid internship or conditional offer of employment with EY's Tax Department in Greater China.
- 3rd prize: HK\$5,000 cash and a 4-week paid internship or conditional offer of employment with EY's Tax Department in Greater China.

International prizes

- 1st prize: A 30-day round-the-world business trip built around working visits to key EY Area Tax Centers in London, Washington D.C. and Hong Kong.
- 2nd prize: A 10-day visit to one of EY's Tax Centers.
- 3rd prize: An invitation to take part in one of our EY's exceptional international client conferences.
