

## ANNUAL SCHOLARSHIP ANNOUNCEMENT DEPARTMENT OF MANAGEMENT



The Department of Management is excited to announce FOUR annual scholarships for outstanding academic performance for Postgraduate programs, Undergraduate Programs and PhD programs.

The Master-degree program scholarship, named "The Department of Management Outstanding Academic Performance Scholarships (Taught Postgraduate Programs)" are TWO annual scholarship

awards worth HK\$20,000 each for outstanding academic performance in the Master of Arts in Global Business Management or Master of Science in Organizational Management programs. These will be awarded to one local and one non-local student who have been the top academic performers in their respective cohorts and have taken at least 12 credit units in Semester A & B respectively in the current year, while also exhibiting good conduct.

Exciting news for all the BBA Management students out there - for outstanding academic performance in the undergraduate program, "The Department of Management Outstanding Academic Performance Scholarships (Undergraduate Program)", shall be presented. In this category, there are NINE awards and each are valued at HK\$10,000. To be eligible for this amazing undergraduate scholarship, you must be a BBA Management undergraduate student who is pursuing their 2nd, 3rd, or 4th year of study in the current year. You need to be the top academic performer in your class in the previous academic year, have taken at least 30 credit units in the previous academic year, and have good conduct.

Next is for the Ph.D. students of the Management department – the annual awards for outstanding service in the PhD program. These awards will be known as "**The Department of Management PhD Service Awards**" and there will be <u>TWO awards given</u>, with each award <u>valued at HK\$15,000</u>. To be eligible for the award, you must be a PhD student in the Department of Management and must have supported the department in the previous year in aspects of internal support to teaching, research, student learning and development, program admission, promotion, development and alumni, etc. Your quality, attitude, impact, and workload of the service(s) provided will also be taken into consideration. Additionally, you must have satisfactory study progress and academic performance, as well as good conduct.



Finally, one more for our BBA Management undergraduates. "The Department of Management Undergraduate Student Service Awards", will be granted to <u>FOUR undergraduate students</u>, each award worth HK\$5,000. To qualify for this award, the quality, attitude, impact, and workload of the service(s) provided to the department of Management, along with meeting the academic performance requirement of CGPA 3.0 or above, along with good conduct is needed.

We believe that these scholarships will serve as a testament to the outstanding academic achievements of our students and will motivate them to strive for excellence in their studies.
